

SPECIAL RELIGIOUS EDUCATION TEACHER DECLARATION

Introductory Comments

The Department of Education requires that all non-employees who are permitted to teach Special Religious Education (SRE) in its schools be appropriate and responsible persons. Each authorised religious persuasion must give an undertaking that any SRE teacher authorised to enter Government schools has not had a criminal conviction within the meaning of the Criminal Records Act 1991.

In keeping with current child protection legislation, all SRE teachers are required to apply for a Working with Children Check and obtain a clearance number. The number and your date of birth must be provided to your approved provider for verification. (NB. This is already provided on the application/renewal form)

In response to the above requirements, Australian Christian Churches NSW have prepared the following declaration, which all ACC NSW SRE teachers must sign.

DECLARATION

I hereby state that I have volunteered my services to Australian Christian Churches NSW, who is an Approved Provider of SRE teachers with the NSW Department of Education.

I declare that:

- I have a current *NSW Working with Children Check* clearance and have provided it to Australian Christian Churches NSW with the date of expiry and my date of birth.
- At the time of engagement, I have no criminal convictions within the meaning of the Criminal Records Act 1991. I understand that 'conviction' defined in the Act includes a conviction, whether summary or on indictment for an offence, and includes a finding or order that an offence has been proved, or that a person is guilty of an offence, without proceeding to conviction.
- I am not subject to any pending court proceedings relating to a criminal matter in Australia or overseas.
- I have no convictions that cannot become spent within the meaning of the Criminal Records Act 1991 including but not limited to:
 - a. convictions for which a prison sentence of more than six months has been imposed, or
 - b. convictions of sexual offences.

I agree that by signing this declaration:

- a. I acknowledge that Australian Christian Churches NSW will keep this declaration on file.
- b. Australian Christian Churches NSW may share this information with the NSW Department of Education when requested.
- a. If during the course of my engagement as an SRE teacher I become a subject of any allegations and/or charges of a criminal matter, court proceedings and/or incur a conviction, I have an obligation and responsibility to notify Australian Christian Churches NSW (sre@nswacc.org.au). I give permission to Australian Christian Churches NSW to disclose this information to the NSW Department of Education and I understand that I may be subject to undertake a Nationally Coordinated Criminal History Check (NCCHC) for a risk assessment.
